

Bingo Blitz Phone Sweepstakes Official Rules

- 1. ELIGIBILITY:** The Sweepstakes is open only to legal residents of the fifty (50) United States and Canada (excluding the Province of Québec), who are 21 years of age or older (“Entrant(s)”).
