- **Purchase Entry:** Players who make in-game purchases and provide their email addresses during the Contest period will automatically be entered into the drawing.
- **Free Entry:** To enter without making a purchase, send an email with your full name, address, and email address to [support@bingoblitz.com] during the contest period.

4. Publicity

The winner will be notified via email or through their account manager. The winner must be available to travel on the specified dates and have all the necessary documents for the trip.

7. Affidavit of Eligibility and Liability/Publicity Release
