

**Bingo Blitz – March-April TV Sweepstakes
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

- 1. OVERVIEW:** The Bingo Blitz – March-April TV Sweepstakes (“Sweepstakes”) comprises five (5) drawings with entry available during five (5) separate Sweepstakes Entry Periods. **You may only enter each Sweepstakes Entry Period one (1) time.** Entry into each Sweepstakes Entry Period is separate. Entry into one Sweepstakes Entry Period is not entry into any other Sweepstakes Entry Period. Prize details in Section 5 below.
- 2. ELIGIBILITY:** The Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia, who are 21 years of age or older (“Entrant(s)”). Employees, officers and directors and their immediate families of Playtika Santa Monica LLC. (“Sponsor”), American Broadcasting Companies, Inc. (“ABC”), Brandmovers, Inc., d/b/a The A Team (“Administrator”), Cara Communications, LLC d/b/a Vin Di Bona Productions (“VDBP”) and the production of America’s Funniest Home Videos (“AFV”), and each of their respective, parents, retailers, distributors, subsidiaries, affiliates, suppliers, advertising agencies, and persons living in the same household as such persons are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state, provincial, local laws and regulations and is void where prohibited by law. Sponsor reserves the right to verify the eligibility and all facts at any time, and Entrants agree to cooperate in any verification process/request.
- 3. SWEEPSTAKES ENTRY PERIODS:** The five (5) separate Entry Periods occur on the dates listed below. Each Entry Period coincides with the broadcast of an AFV episode as set forth in the table below. Each Entry Period begins at the time the AFV broadcast begins, and the Bingo Blitz in-game Sweepstakes popup becomes available and ends twenty-five (25) hours thereafter (each an “Entry Period”).

Entries must be submitted within the designated Entry Period to be eligible. The Sponsor’s database clock will be the official timekeeper for this Sweepstakes.

- 4. HOW TO ENTER:** During an official Entry Period as described above, log into your free Bingo Blitz account (“Account”) via the free Bingo Blitz mobile game app (the “App”). Once you are logged into your Account a popup will appear as part of the normal in-game launch sequence. Click on the Sweepstakes popup to access the Sweepstakes Registration Form. Complete and submit the form with your full name and a valid email address to receive one (1) entry for that Entry Period. Important: You must be logged into the App with a registered Account. Entries submitted from guest accounts will not be accepted. If you experience issues accessing your Account, contact bsocialmedia@playtika.com. Limit: One (1)

entry per person per Entry Period. Duplicate entries or entries submitted using multiple email addresses, Accounts, identities, or automated methods will be disqualified.

Any attempt to enter more than once during any Entry Period by any means, including, but not limited to, use of multiple identities, email addresses, Accounts, or other means, may result in disqualification from this and any other promotional offerings by Sponsor. Use of any macro, bot, script or other automated means to submit entries is prohibited. No responsibility is assumed for lost, late, damaged, misdirected, illegible, incomplete, incorrect entries or other sweepstakes materials, all of which are void, or for errors due to computer malfunctions, software errors, transmission problems or interruptions in operations. In the event of a dispute over the identity of an entrant, entry will be deemed submitted by the authorized account holder of the e-mail account of the e-mail address associated with the Account associated with the entry. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Sweepstakes entrants must use legal name as it appears on government-issued identification, and not under any pseudonym, alias, or assumed identity. The use of a pseudonym, alias, or any name other than my legal name shall be grounds for immediate disqualification by Sponsor.

- 5. RANDOM DRAWING AND WINNER NOTIFICATIONS:** Five (5) potential winners will be randomly selected from among all eligible entries received during each of the five (5) Entry Periods. The drawings will occur based on the chart in Section 3 above. Entrants irrevocably agree to be bound by these Official Rules, which are final and binding in all respects.

Each potential winner will be notified using the email address associated with their Account. No liability is assumed for any winner notification that is lost, intercepted or not received by a potential winner for any reason. Failure to comply when requested may result in disqualification and selection of an alternate winner. If a potential winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines a prize for any reason prior to award, such potential winner will be disqualified and an alternate winner may be selected. Any potential winner, as a condition to receiving any prize, may be required to sign and return a declaration of eligibility and liability/publicity release or similar document and complete, sign, and submit to Sponsor or Administrator an IRS Form W-9 or equivalent form with all required information within five (5) days of notification to winner of his/her prize eligibility. - 5. PRIZES AND APPROXIMATE RETAIL VALUE ("ARV"):** There will be five (5) prizes offered in this Sweepstakes, one (1) prize per Entry Period: \$1,000 Visa® Gift Card. ARV: \$1,000.00. Visa terms and conditions may apply to the Prize and redemption thereof. Visa is not a sponsor of or in any way affiliated with the Sweepstakes. Limit one (1) prize per person and per household. Prizes are non-transferable and may not be substituted or redeemed for cash, except at Sponsor's sole discretion. Sponsor reserves the right to substitute a prize of equal or greater value.

6. **ODDS:** Odds of winning depend on the total number of eligible entries received for each of the five (5) Entry Periods.
7. **MISCELLANEOUS:** Sponsor is not responsible for any (a) lost, late, misdirected, damaged, garbled, incomplete or illegible entries, all of which are void; (b) telephone, computer, mobile device, hardware, software, programming or network malfunction or other technical failures or errors, or the failure to properly process entries; (c) communication disruption or other forces beyond the reasonable control of the Sponsor, including but not limited to disruption related to internet traffic, wireless networks, virus, bug or non-authorized intervention; or (d) damage caused by a computer or mobile device related virus or otherwise resulting to any computer or mobile device from such person's participation in the Sweepstakes whether human, mechanical or electronic. Sponsor reserves the right to modify, extend, suspend, or terminate the Sweepstakes, in whole or in part, if it determines, in its sole discretion, that the Sweepstakes is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other unintended circumstances have impaired the integrity, administration, security, proper play and/or feasibility of the Sweepstakes as contemplated herein. If the Sweepstakes is terminated before the end date, Sponsor will post a notice on <https://www.bingoblitz.com> and, to the extent possible, winner(s) will be selected from among all eligible entries unaffected by any error that were received as of the termination date. Entries that contain errors or are incomplete or received after the relevant entry period, will not be accepted.
